Notice is hereby given that the Annual General Meeting of members of Highland Deephaven Clay Pigeon Club will be held on **Thursday 15th March at 18:30** in the clubhouse, Highland Deephaven Industrial Estate, Evanton.

The main item on the agenda is the formal formation of a limited company and the transfer of assets etc. from the club to the proposed limited company. Should the motion to form a limited company be successful then we will require appoint a board of directors (minimum of 5). Directors are required to be nominated prior to the AGM and can be seconded by another member at or prior to the AGM. Any nominations should be sent to Gilly Naisby (secretary).

The main reason for becoming a limited company is to protect you the member, the committee and office bearers should there ever be an incident which results in the club having to fold. If this happened, members would be limited to a liability of only £1 each. Also, the assets of the club (traps, acoustics, clubhouse, storage containers etc.) will not belong to any directors or individuals and can be dispersed to other clubs should the club fold without owing any money. The limited company will be set up as a "not for profit" company.

I would stress that the club is in a strong position at present and not likely to fold. It will give us the opportunity to gain a lease and then hopefully grants to improve the shooting ground. There are additional costs in setting this up, but we currently have funds to cover this and the intention is to continue running the club in the same manner, keeping the shooting at an affordable level.

There will be an ad-hoc DTL\Skeet practice before the meeting from 16:00-18:00. Tea, coffee and cake will be available before the meeting starts.

I would like to take this opportunity to thank everyone who has helped keep the Club running efficiently in the past year.
